

## CONTRACT FOR SERVICES

### **By Sweet Voodoo with Scotts Valley Kiwanis Foundation (aka Kiwanis)**

This contract is made on 4/9/2026 between **Veda Ozelle** representing the band **Sweet Voodoo** and **Raymond Gorski** for **Scotts Valley Kiwanis Foundation**, each of whom agree to the following terms and conditions:

**Sweet Voodoo** hereby agrees to perform on **August 30, 2026** for the Music at Sky Park concert series, for a 1 1/4 hr. performance from **1:30pm to 3:00pm** with one optional break of ~15 minutes about halfway through the performance.

Your band will be the **Opener** and will be followed **Extra Large** who will perform from **3:45pm to 5:15pm**

In consideration of this performance, Kiwanis agrees to pay **Sweet Voodoo, \$650**. The Check will be made payable to **Veda Ozelle** and will be paid at the performance. If for any reason this function is cancelled at least 30 days prior to performance date, no payment will be due the band. All contractual agreements are confidential.

**Sweet Voodoo** shall be provided with the following:

- Covered Stage (Y)
- Power (Y)
- Sound System (Y)
- Sound Technician (Y)
- Food & Refreshments (Y - water plus 10 tickets for each band member for food and/or drink)

**Sweet Voodoo** agrees to accommodate the following requests:

- Load in time: **12:30pm**
- Load in location: **Sky Park, Scotts Valley**
- Sound check time: **1:15pm**

### **Marketing and Promotional Cooperation**

The purpose of this section is to facilitate reciprocal marketing efforts intended to increase awareness and attendance at the Event. Each party agrees to act in good faith in supporting such promotional efforts, consistent with their respective branding and communication standards.

### **Band Promotional Materials.**

**Sweet Voodoo** agrees to provide to Kiwanis, the following promotional materials in digital format ASAP:

Kiwanis shall have sole discretion to determine whether and how such materials are used, and shall have no obligation to use any or all materials provided.
